The State Level Executive Committee shall –

- i) take all steps for giving effect to the State CAMPA and overarching objectives and case principles, in accordance with rules and procedures approved by the Steering Committee and the approved APO;
- ii) purpose the APO of the State for various activities, submit it to the Steering Committee before end of December for each financial year, and obtain the Steering Committee's concurrence for release of funds, while giving break-up of the proposed activities and estimated costs;
- iii) supervise the works being implemented in the State out of the fund released from the State CAMPA;
- iv) be responsible for proper auditing of both receipt and expenditure of fund;
- v) develop the code for maintenance of the account at the implementing agency level;
- vi) submit reports to the Steering Committee for review/consideration; and
- vii) prepare Annual Report by end June for each financial year.
